RLF/UDAG – March 21, 2019:

- Approved the minutes of September 20, 2018.
- Recommended Council keep the defederalized RLF funds in a separate account under the control of the RLF/UDAG Committee.
- Recommended Council authorize the Clerk at the direction of the Chair to invest the RLF cash in a Marinette County institution as she sees best.
- Recommended Council enter into a contract to buy a property at the maximum price discussed in closed session provided the results of a study show there are at least 15 buildable acres on the site and to use up to \$5,000 of UDAG funds or RLF funds as secondary to conduct the study with UP Engineering.

Parks & Recreation – March 22, 2019:

- Approved the minutes of January 11, 2019.
- Recommended Council approve increasing the Hometown Hero Banner fee to \$150.00 each with a limit of thirty new banners for 2019.
- Forwarded to the Finance Committee to explore options to fund the replacement of banner arms and the purchase of new banner arms.
- Authorized Director Zahn to work with department heads to complete a Request for Proposal for a security system and recommended Council approve advertising for RFP's.
- Discussed potential programs for Parks and Recreation Spring/Summer 2019 Program Guide.
- Authorized Parks & Recreation Director Zahn to distribute the Needs Assessment Survey as presented in with the April water bills and at City Hall.
