

Amendment to Chapter 2 (Administration), Article II (Common Council) of City Ordinances

That Article II of Chapter 2 of the Code of Ordinances, City of Peshtigo, Wisconsin is hereby amended to read as follows:

DIVISION 5: WATER AND SEWER COMMITTEE

Sec. 2-139. Water and Sewer Committee

- (a) There shall be a Committee designated as the Water and Sewer Committee. The Committee shall consist of three (3) voting members appointed annually by the Mayor at the common council reorganizational meeting held on the third Tuesday of April.
- (b) The active public works director for the City shall be an ex officio member of the Committee.

DIVISION 6. INDUSTRIAL PARK OVERSIGHT COMMITTEE

DIVISION 7. URBAN DEVELOPMENT ACTION GRANT (UDAG) COMMITTEE

Sec. 2-169. Urban Development Action Grant (UDAG) Committee

- (a) There shall be a Committee designated as the Urban Development Action Grant (UDAG) Committee. The Committee shall consist of five (5) members, one of which shall be an acting council member. Three members shall constitute a quorum at any duly called meeting. The Committee shall elect its own Chairperson. The City shall pay each member on a per diem basis as determined by the Common Council on an annual basis.
- (b) To facilitate and enable this Division, the Mayor is hereby authorized and directed to select the five current members of the Committee existing as of January 1, 2012 to serve as the initial members of the Committee with the following terms: The acting council member shall be appointed annually to a one-year term; two (2) of the members shall be appointed to a two-year term and two (2) of the members to be appointed to a three-year term. Thereafter, the Mayor, shall annually, at the reorganizational meeting of the common council held on the third Tuesday of April, make appointments to the Committee as terms of the members expire. The new term of each member so appointed shall be for a term of three (3) years.

DIVISION 8. WISCONSIN DEVELOPMENT FUND (WDF) COMMITTEE

Sec. 2-178. Wisconsin Development Fund Committee

- (a) There shall be a Committee designated as the Wisconsin Development Fund (WDF) Committee. The Committee shall consist of five (5) members, one of which shall be an acting council member. Three members shall constitute a quorum at any duly called meeting. The Committee shall elect its own Chairperson. The City shall pay each member on a per diem basis as determined by the Common Council on an annual basis.
- (b) To facilitate and enable this Division, the Mayor is hereby authorized and directed to select the five current members of the Committee existing as of January 1, 2012 to serve as the initial members of the Committee with the following terms: The acting council member shall be appointed annually to a one-year term; two (2) of the members shall be appointed to a two-year term and two (2) of the members to be appointed to a three-year term. Thereafter, the Mayor, shall annually, at the reorganizational meeting of the common council held on the third Tuesday of April, make appointments to the Committee as terms of the members expire. The new term of each member so appointed shall be for a term of three (3) years.
