

ORDINANCE NO. 2014-03

AMENDING VARIOUS ORDINANCES REGARDING

LICENSE AND PERMIT FEES

The Common Council of the City of Peshtigo, Wisconsin, do ordain as follows:

SECTION 1. The following Sections of the Code of Ordinances of the City of Peshtigo are amended to read as hereafter provided:

(1) SEC. 2-429 (a) is amended to read:

(a) There shall be a Thirty-five Dollar (\$35.00) fee for processing **checks** made payable to the City that are returned because of **insufficient funds** in the account in question.

(2) SEC. 6-48 (1) is amended to read:

(1) **Class "A" Fermented Malt Beverages Retailer's License.** The annual fee for this license shall be One Hundred Fifty Dollars (\$150.00). The fee for a license for less than twelve (12) months shall be prorated according to the number of months or fraction thereof for which the license is issued.

(3) SEC. 6-48 (2) is amended to read:

(2) **Class "B" Fermented Malt Beverage License.** The annual fee for this license shall be One Hundred Dollars (\$100.00). This license may be issued at any time for six (6) months in any calendar year, for which fifty percent (50%) of the applicable license fee shall be paid, but such license shall not be renewable during the calendar year in which issued. The fee for a license for less than twelve (12) months shall be prorated according to the number of months or fraction thereof for which the license is issued.

(4) SEC. 6-48 (6) is amended to read:

(6) **"Class A" Intoxicating Liquor Retailer's License.** The annual fee for this license shall be Three Hundred Fifty Dollars (\$350.00).

(5) SEC. 6-48 (7) is amended to read:

(7) **"Class B" Intoxicating Liquor Retailer's License.** The annual fee for this license shall be Three Hundred Dollars (\$300.00). This license may be issued at any time for six (6) months in any calendar year, for which fifty percent (50%) of the applicable license fee shall be paid, but such license shall not be renewable during the calendar year in which issued.

(6) SEC. 6-112 (a) is amended to read:

(a) For an **operator's or provisional** license: Twenty-Five Dollars (\$25.00).

(7) SEC. 8-47 (3) is amended to read:

(3) For **dog and cat licenses**: For unspayed or unneutered animals a fee of Ten Dollars (\$10.00). For spayed or neutered animals a fee of Five Dollars (\$5.00)

(8) SEC. 8-136 is amended to read:

(a) For **animal impoundment fees**: Twenty-Five Dollars (\$25.00).

(9) SEC. 10-140 is amended to read:

(a) **Fees for Building Permits and Inspections**. At the time the application for a building permit is filed, the applicant shall pay the following fees:

New industrial buildings (Includes water and sewer)	\$500.00

Industrial remodeling and additions	\$50.00
Private garages and sheds	\$30.00
Signs	\$30.00
Sewer Permit	\$30.00
Water Permit	\$30.00
Razing Permit	\$30.00
Moving-out-of-town Permit	\$30.00
Moving and relocating within the city (Includes water and sewer)	\$50.00
Moving and relocating within the city (Without water and sewer)	\$30.00
Flammable liquid storage	\$30.00
Outdoor Wood Burning Heating Units	\$100.00

(10) SEC. 12-47 (b) is amended to read:

(b) **Cigarette Licenses: Application for License; Fee**. Every person desiring a license under this section shall file with the City Clerk-Treasurer a written application thereof, stating the name of the person and the place for which such license is desired.

Each license shall be filed by the City Clerk-Treasurer and shall name the licensee and the place wherein he is authorized to conduct such business, and the same shall not be delivered until the applicant shall pay to the City Clerk-Treasurer a license fee of One Hundred Dollars (\$100.00).

(11) SEC. 12-71 (c) (1) is amended to read:

(c) (1) **Registration Fee.** At the time of filing applications, a fee of Fifty Dollars (\$50.00) shall be paid to the City Clerk-Treasurer to cover the cost of investigation of the facts stated in the applications and for processing said registration. Every member of a group must file a separate registration form.

(12) SEC. 34-47 (b) is amended to read:

(b) **Application for License; Fee.** Every person, firm or corporation desiring a license under this Section shall file with the City Clerk-Treasurer a written application therefor, stating the name of the person and the place for which such license is desired. Each license shall be filed by the City Clerk-Treasurer and shall name the licensee and the place wherein he is authorized to conduct such business, and the same shall not be delivered until the applicant shall pay to the City Clerk-Treasurer a license fee of Fifty Dollars (\$50.00).

(13) SEC. 34-52 is amended to read:

(a) For **secondhand article dealer's license:** Thirty Dollars (\$30.00).

(14) SEC. 52-831 (i) is created to read:

(i) **Fee for Fence Permit.** At the time the application for a fence permit is filed, the applicant shall pay a fee of Thirty Dollars (\$30.00).

(15) SEC. 52-832 (c) is amended to read:

(c) **Permit Required.** Before work is commenced on the construction or erection of private or residential **swimming pools** or on any alterations, additions, remodeling or other improvements, an application for a swimming pool building permit to construct, erect, alter, remodel or add must be submitted in writing to the Building Inspector. Plans and specifications and pertinent explanatory data should be submitted to the Building Inspector at the time of application. No work or any part of the work shall be commenced until a written permit for such work is obtained by the applicant. A fee of Thirty Dollars (\$30.00) shall accompany such application.

(16) SEC. 52-862 (g) is created to read:

(g) **Fee for Mobile Home Park Developer's Permit.** At the time of issuance of a Mobile Home Park Developers Permit, the applicant shall pay a fee of Five Hundred Dollars (\$500.00).

(17) SEC. 52-893 (4) is created to read:

a. **Fee for Solar Access Permit.** At the time of issuance of a solar access permit, the applicant shall pay a fee of Twenty-Five Dollars (\$25.00).

(18) SEC. 52-928 (1) is amended to read:

(1) **Rezoning Application.** One Hundred Fifty Dollars (\$150.00) per application (including repetitions of previous applications).

(19) SEC. 52-928 (2) is amended to read:

(2) **Conditional Use Permit Application.** All conditional use applications shall be filed with the City Clerk-Treasurer along with a One Hundred Fifty Dollar (\$150.00) filing fee. The filing fee shall be used to reimburse the City for publication costs and attorney's fees incurred in relation to the application and hearings thereon. After final decision on the application, the City Clerk-Treasurer shall return the balance of the filing fee, if any, to the applicant. The City Clerk-Treasurer, upon receipt of an application and the fee provided herein, shall immediately refer it to the Plan Commission for consideration.

(20) SEC. 52-928 (3) is amended to read:

(3) **Variance Application.** All applications for special exceptions and variances and appeals shall be filed with the City Clerk-Treasurer along with a One Hundred Fifty Dollar (\$150.00) filing fee. The filing fee shall be used to reimburse the City for publication costs and attorney's fees incurred in relation to the application or appeal and hearings thereon. After final decision on the application or appeal, the City Clerk-Treasurer shall return the balance of the filing fee, if any, to the applicant or appellant. The City Clerk-Treasurer, upon receipt of an application or appeal and the fee provided herein, shall immediately refer it to the Board of Appeals for consideration.

(21) SEC. 52-928 (5) is amended to read:

(5) **Zoning and Occupancy Permit Application.** Thirty Dollars (\$30.00).

SECTION 2. This ordinance shall take effect upon passage and publication.
